775 acres of wooded land including two of the highest points in Town - 4 miles existing wood roads - 1 1/2 miles of trails - suitable for cross-country skiing and horseback riding - abutting Town-owned bridle trail for 2500 feet.

9. SILVER PINES LOTS

128 acres, interesting historical and natural history area adjacent to ball fields - Home Bog, excellent water bird habitat - Upland portions; Slaughter's Island and Cherry Hill (site of Daniel Webster's last speech) - 2 miles of trail.

32 acres of wet meadow and marshland adjacent to Bass Creek - scattered wet lots.
